
## 2024-2025 Original Budget Assumptions - March 15, 2024


## **Assumptions Used**

### o Revenue

- 18.0000 Mills of Non-Homestead tax levy and 6.0000 Mills of Commercial Personal tax levy 2023 property values
- o 3% increase in taxable values from May 2023 original values
- o Declining interest rates throughout 24/25
- o Removed Bosch Foundation grant
- o Foundation of \$9,708 per pupil \$100 increase from 23/24
- Count funding formula based on 10% of previous February count and 90% of current fall count
- o Enrollment change of (36.25) FTE Students from 23/24 Blended Count
  - Un-audited February 2024 Count = 3,081.96
  - Estimated October 2024 Count = 3,056.00

- o Increase in Sec. 31a At-Risk Funding

- Includes remaining ESSER III and ARP ESSER III 11t Funds for summer school and August professional development only
- o 3% Increase in Special Education Millage from the MISD

    - No changes to staffing levels

    - 1.0 FTE Additional ECSC Paraprofessional position
- o Administrator Steps included
- Additional GSRP Classroom Teacher and Aide positions added
- o Increased athletic coaching salaries based on Teacher CBA
- o Dock/Unpaid Days restored
- o Added Warren Woods Leadership Academy Intern position
